Ms. Koch asked why it takes so long for the meeting minutes to be posted on the website. Mrs. Nasuto said we post the minutes after they've been approved at a Mayor & Council meeting. Ms. Koch said at the last meeting you said you had no interest in streaming your meetings live. Is there a reason why? Mayor Romeo said we've discussed it and are not interested in doing it. Our meeting minutes are posted on our website for anyone interested in what's going on. Council Member Olmo said if we on the dais have the time to come to meetings, anybody that has an interest can also come down. Council Member Tsigounis said we would like to see more people attend so please spread the word.

Mr. Calabrese asked who the Borough's Administrative Agent for COAH is. Mayor Romeo said we are currently interviewing because our last agent retired. Mr. Calabrese asked about zoning districts for accessory apartments. Mayor Romeo said it's the residential zones. If you wanted to add an accessory apartment for a relative, we can help finance it with our COAH funds. It would be added to your deed and have to stay on for 20 years. The Administrative Agent would be the one to qualify them financially. But if that apartment were to become vacant, you could not rent it out. Mr. Calabrese said there's a house on his block that's had an illegal apartment since 1995. Could she get COAH money now? Mayor Romeo said absolutely not and please give me the address and we'll check it out. Mr. Calabrese said he did not want that particular tenant kicked out because he knows him. Mayor Romeo said you can't pick and choose. Mr. Calabrese said he asked a while back if someone was going to check the internet for Airbnb ads. Mayor Romeo said that would fall under the new Property Maintenance Officer.

Ms. Koch said you mentioned you needed volunteers. I wouldn't mind volunteering, but only for Facebook. Ms. Koch asked if the Mayor & Council volunteered their time or got paid. Mayor Romeo said they do not get a stipend or a salary.

No one else wished to be heard.
