RESOLUTION AUTHORIZING THE BOROUGH OF CRESSKILL TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1994, C.72

WHEREAS, due to the County Board of Taxation unable to certify a tax rate due to various issues at the state level and the Municipal Tax Collector will be unable to mail the tax bills on a timely basis, it has become necessary to issue estimated tax bills for the 3rd quarter of 2018; and

WHEREAS, the Municipal Tax Collector, in consultation with the Municipal Chief Financial Officer, has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated levies;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Cresskill, in the County of Bergen and State of New Jersey on the 16th day of May 2018 as follows:

- 1. The Borough of Cresskill Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Borough for the third installment of 2018 taxes. The Tax Collector shall proceed and take such actions as necessary.
- 2. The entire estimated levy for 2018 is hereby set at \$50,871,777.00 for an estimated tax rate of \$2.412.

WHEREAS, the Borough is of the opinion that this position should be outsourced and has interviewed various entities; is of the opinion the Community Grants, Planning & Housing (CGP&H) of Cranbury, New Jersey, is the most qualified company and should be appointed the Borough's Affordable Housing and Administrative Agent; and

WHEREAS, CGP&H is an approved New Jersey Department of Community Affairs Affordable Housing Administrative Agent; and

WHEREAS, CGP&H is currently responsible for monitoring thousands of units of affordable housing throughout 40 municipalities in New Jersey.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Cresskill, in the County of Bergen and State of New Jersey does hereby appoint CGP&H as its Affordable Housing Administrative Agent.
