BOROUGH OF CRESSKILL ORDINANCE NO. 18-03-1515

AN ORDINANCE TO AMEND CHAPTER 263 - VEHICLES AND TRAFFIC

WHEREAS, the Mayor and Council of the Borough of Cresskill in an effort to increase safety on public roadways and with the recommendation of the Cresskill Police Department, Traffic Bureau Division; adopted Ordinance No. 17-07-1501; and

WHEREAS, after feedback from residents and further monitoring by the Traffic Bureau Division, the Mayor and Council agree to amend sections of that ordinance.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Cresskill, in the County of Bergen and State of New Jersey, as follows:

SECTION I:

SECTION 263-32. Schedule I: No Parking.

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by <u>adding</u> thereto the following:

In accordance with the provisions of Section 263-7, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street	Side	Location
East Madison Avenue	North	From Legion Drive to County Road
East Madison Avenue	Both	From Piermont Road to Legion Drive

SECTION II:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-33. Schedule II: No Parking Certain Hours.

In accordance with the provisions of Section 263-8, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Brookside Avenue	Both	8:00 a.m. to 4:00 p.m. school days	From Bergen Terrace to Grant Avenue
Lexington Avenue	North	8:00 a.m. to 4:00 p.m. school days only	Between Brookside Avenue and Roosevelt Street

SECTION III:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by <u>adding</u> thereto the following:

SECTION 263-35. Schedule IV: Parking Time Limited.

In accordance with the provisions of Section 263-10, no person shall park a vehicle for longer than the time limit shown upon any of the following streets or parts of streets:

Name of Street	Side	Time Limit; Hours/Days	Location
Ackerman Avenue	West	2 hrs. School days 8 a.m. to 4 p.m.	Entire Length
Dogwood Lane	East	Standing only School Days 8 a.m. to 4 p.m.	Between Borough Hall emergency entrance and Margie Avenue
Margie Avenue	Both	2 hrs. School days 8 a.m. to 4 p.m.	Dogwood Lane to Ackerman Avenue

SECTION IV

All other Ordinances of the Borough, or parts thereof, which are in conflict with this Ordinance, are hereby repealed to the extent of such conflict.

SECTION V

If any section, subsection, paragraph, subdivision, or sentence of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such decision shall apply only to the section, subsection, paragraph, subdivision, sentence, clause, phrase or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.

SECTION VI

This Ordinance shall take effect immediately upon final passage and publication according to law.
