18. RENEWAL OF MEMBERSHIP IN THE BERGEN COUNTY MUNICIPAL JOINT INSURANCE FUND

WHEREAS, the Borough of Cresskill is a member of the Bergen County Municipal Joint Insurance Fund; and

WHEREAS, said renewed membership terminates as of December 31, 2021 unless earlier renewed by agreement between the Municipality and the Fund; and

WHEREAS, the Municipality desires to renew said membership;

NOW, THEREFORE, be it resolved as follows:

- 1. The Borough of Cresskill agrees to renew its membership in the Bergen County Municipal Joint Insurance Fund and to be subject to the Bylaws, Rules and Regulations, coverages, and operating procedures thereof as presently existing or as modified from time to time by lawful act of the Fund.
- 2. The Mayor and Clerk shall be and hereby are authorized to execute the agreement to renew membership annexed hereto and made a part hereof and to deliver same to the Bergen County Municipal Joint Insurance Fund evidencing the Municipality's intention to renew its membership.
- 19. WHEREAS, the Borough has received numerous complaints regarding the real property known as 125 13th Street, Cresskill, New Jersey, 07626, with the owner of record being Jae Choi; and

WHEREAS, the complaints received by the Municipality include, but are not limited to, failure to maintain the property, specifically Lawn and Shrubbery Care; and

WHEREAS, the property owner was Noticed on June 10, 2021, to immediately mow the lawn and trim overgrown trees and shrubbery, or be subject to the Municipal Penalties; and

WHEREAS, it was brought to the Borough's attention that the Property Owner, Jae Choi, was charged and indicted by the United States Attorney's Office for obtaining approximately \$9,000,000.00 in payment protection program (PPE) loans and has abandoned the premises at 125 13th Street, Cresskill, New Jersey; and

WHEREAS, as a result of the abandonment of the premises by Jae Choi, the health and safety issues raised by the failure to maintain the grass height at a reasonable level has resulted in the Borough ordering the Department of Public Works to "clean up" and "maintain" the property to Municipal Standards; and

WHEREAS, on June 29, 2021, the Department of Public Works directed its crew to commence a cleanup of the property; and

WHEREAS, the Department of Public Works has issued an invoice outlining the machinery and labor utilized to clean the property; and

WHEREAS, the labor and machinery expended by the Municipality to clean the property totaled five hundred thirty-eight dollars and fifty-eight cents (\$538.58);

NOW, THEREFORE BE IT RESOLVED, the Council does hereby direct the Cresskill Chief Financial Officer Alison Altano to file a tax lien in the amount of \$534.58 against the property 125 13th Street, Cresskill, New Jersey, 07626, as a result of the "cleanup" of the abandoned property and to maintain the Municipality's requirement to maintain the property and to restore the land to Municipal health and safety standards.
