Council Member Tsigounis said the Senior Board of Trustees have scheduled a trip to Broadway on May 1<sup>st</sup> for \$175. The cost covers a show, transportation and dinner. The Library Board is looking for members to join the Library Foundation, which is the new non-profit they've established.

Council Member Savas gave an update on plans for the quasquicentennial. Historian Tom Sites has become very involved. The students are going to do a time capsule. We'll have a bus tour of historical locations in town. Also, a scale model of Cresskill, circa 1924, is going to be built and put on display.
