

o. No thong bathing suits permitted.

## V HEALTH AND SAFETY

a. All bathers must shower before entering pool. A shower must also be taken to remove suntan oil before entering pool.

b. Admission to the pool shall be refused to anyone with colds, coughs, inflamed eyes, infections or wearing bandages. Sanitary habits must be observed.

c. No pets allowed on the pool property.

d. No glass containers of any kind will be allowed in the pool area.

e. No running, pushing, wrestling, or causing undue disturbance in or about the pool area.

f. Life jackets, underwater masks, swimmies, flippers, snorkels, etc. will not be permitted in the pool, except at manager's discretion.

g. Expectorating and nose blowing in the pool is prohibited.

h. Diving will be permitted only in designated areas. Do not climb out side of pool. Must exit from ladder.

i. Parents should make certain that their children make periodic visits to bathrooms.

j. All members and guests are to wear proper clothing for bathing or sunning at all times, including small children and infants.

k. No street clothing, cutoffs, or socks, with the exception of white tee shirts, will be worn in the pool.

l. People using athletic area and/or sandbox must wash feet before entering pool using outdoor shower.

m. The manager will exercise discretionary judgment in all matters governing the pool operation.

## VI GENERAL RULES

a. All persons using any of the pool facilities do so at their own risk. The pool will not be responsible for any accident or injury in connection with such use.

b. The pool will not be responsible for loss or damage to personal property.

c. Parking should be restricted to designated areas only.

d. All suggestions or complaints should be brought to the attention of the manager or assistant manager.

e. Guest privileges may be restricted at any time at the discretion of the manager when it appears an overcrowded condition exists and the safety of the members may be impaired. Guest are required to wear wrist bands.

f. These rules and regulations may be revised at any time by the Commission. Notice of any changes or additions will be posted on the pool bulletin board.

g. Members and guests must conduct themselves in an orderly fashion while on pool grounds or be subject to suspension.

h. Slide Rules are posted near slide. Children must be able to swim unaccompanied to ladder. No one is permitted in designated slide area to catch non swimmers.

i. Lightening Detector: Patrons must evacuate pool grounds immediately.

j. By entering the premises, you consent to photos or videos being taken of yourself and any listed members. These images may be used for promotional purposes, including social media and other digital platforms, to showcase and promote the pool and its activities.

### RULES AND REGULATIONS

Revised Feb. 2024

DEAR MEMBER:

THE FOLLOWING RULES AND REGULATIONS ARE FOR THE PROTECTION AND BENEFIT OF ALL MEMBERS. THESE RULES AND REGULATIONS HAVE BEEN ESTABLISHED NOT ONLY TO ASSURE SAFE AND SANITARY OPERATION OF THE POOL AND FACILITIES BUT, TO ASSURE A PLACE OF GREAT ENJOYMENT FOR YOU. PARENTS ARE REQUESTED TO ACQUAINT THEIR CHILDREN WITH THESE RULES AND TO CAUTION THEM TO OBSERVE ALL RULES AND OBEY INSTRUCTIONS OF THE POOL MANAGER AND OTHER EMPLOYEES. **ANY FAILURE TO COMPLY WITH THESE RULES SHALL BE CONSIDERED SUFFICIENT CAUSE FOR IMMEDIATE SUSPENSION OF POOL PRIVILEGES FOR THE OFFENDING MEMBER FAILURE TO COMPLY MAY ALSO BE CONSIDERED SUFFICIENT CAUSE FOR CANCELLATION OF MEMBERSHIP.**

### I GENERAL ADMISSION

a. **ELIGIBILITY** Residents of the Borough of Cresskill, full-time employees, non-resident families sponsored by resident members, and those non-residents who pay local property taxes to the Borough of Cresskill, are eligible for membership in the municipal pool. The Municipal Pool Commission reserves the right to review proof of residency and such other documentation that may affect membership status.

b. **APPLICATION FOR MEMBERSHIP** Every application must be made in the name of an individual who meets the eligibility requirements and is at least 18 years of age. In the event of an individual membership application for a minor the application must be made in the name of the parent or guardian **EVEN THOUGH THE PARENT OR GUARDIAN IS NOT JOINING.** In each case the applicant should be the "head of the household."

### c. TYPES OF MEMBERSHIP

**Family:** This membership may include 2 members residing at same address. This type of membership may also include any and all children who are unmarried and are between the ages of 3 and under 23 by the current swimming season. There is no

charge for children under three years of age.

**Individual:** Any one person is eligible for an individual membership provided he/she meets the eligibility requirements above and is at least 16 years of age by the current swimming season. In the event that the individual is a minor the applicant shall be a parent or guardian as provided above under "application for membership."

**Senior Citizen:** Any person who meets the above eligibility requirements and has reached his/her 62nd birthday by the current swimming year may receive a senior citizen membership. In addition, the spouse/cohabitant of a senior citizen may receive this same type of membership even though the spouse may not have reached his/her 62nd birthday. Since this is not a family type membership, no children may be included in this type of membership.

**Sponsored:** Non-resident families sponsored by resident members.

**Monthly:** Cresskill residents can now enjoy the municipal pool with a flexible monthly membership option for July 1-31 or August 1-31. Perfect for those who want to beat the heat without committing to a full season, this membership provides full pool access while excluding additional programs like swim team, lessons, or aqua fit classes. Choose one month or both.

**d. MEMBERS OF THE ARMED FORCES:** Residents of the Borough of Cresskill who are on active duty with the Armed Forces of the United States shall be allowed to swim free provided they present to the pool office evidence they are on active duty.

**e. REGULAR GUESTS:** Each member family shall be allowed guest privileges. A guest privilege shall consist of admission to the pool area of each individual for the entire day schedule. **CONDUCT OF GUESTS IS THE DIRECT RESPONSIBILITY OF THE SPONSORING MEMBER.** A guest must be accompanied by a member at least 16 years of age.

**f.** Any member who feels he has a special case should communicate such case in writing to the Commission prior to the start of the season.

## II POOL HOURS

a. Monday thru Friday Noon to 8:00 p.m.; Saturdays, Sundays & Holidays 11:00 a.m. to 7:00 p.m.

b. SWIMMING INSTRUCTIONS. Group swimming instruction Monday thru Thursday 9:30 a.m. to 11:30 a.m. Schedules will be posted on Facebook and the information board on site.

c. The pool may be closed for maintenance operations, health conditions, weather, or any other reason deemed sufficient by the Pool Manager.

d. Season will be from Memorial Day weekend through Labor Day. Schedule for June will be posted on bulletin board and Facebook.

e. If the temperature exceeds 85° at 1:00 p.m. and weather permitting, an attempt will be made to open the pool at 4:00 p.m. on weekdays **during the month of June.**

## III RULES GOVERNING ADMISSION OF CHILDREN TO POOL AREA

a. Children 10 years and under must be accompanied by a responsible person at least 16 years of age at all times.

b. Swimming area may be cleared of children at the discretion of the pool manager for one 15 minute adult swim per hour.

c. The kiddie pool will be limited to children under 6 years of age. **CHILDREN MUST BE SUPERVISED BY AN ADULT OTHER THAN THE LIFEGUARD AT ALL TIMES.** All children must wear bathing suits in kiddie pool.

d. **CHILDREN NOT TOILET TRAINED MUST WEAR SWIM DIAPERS UNDERNEATH A BATHING SUIT IN THE KIDDIE POOL AND WILL NOT BE ALLOWED IN THE MAIN POOL**

e. No children in diapers or under the age of three will be allowed in the main pool during regular hours.

f. No flotation devices in the main or kiddie pools.

## IV MEMBER OBLIGATIONS AND CONDUCT

a. The Cresskill Municipal Pool is a **non-smoking facility.**

b. Misuse of membership rules will result in immediate expulsion from pool grounds of the particular unauthorized

person and member will be subject to the following penalties:

First Violation- Warning

Second Violation- One week suspension

Third Violation- Minimum two week suspension

plus appearance with parents before Commission.

Fourth Violation- Permanent suspension of membership.

c. Vehicles must be driven slowly and carefully on access roads and in the parking lot. Excessive speeds and any other form of annoyance to our neighbors must be avoided. Traffic patterns in our parking lot must be strictly observed.

d. All bicycle riders will use bicycle racks and ride carefully. Bicycles left in racks should be secured with a lock.

e. Cost of any property damage will be charged to the responsible member.

f. State regulations prohibit alcoholic beverage on pool grounds. Any person considered by the pool management to be under the influence of liquor will be denied access to the premises.

g. Chairs, lounges, and/or tables cannot be reserved by or for members of guests who are not on the pool premises. Such pool property is restricted for use by persons over 18 years of age on weekends and/or crowded days. If there is a shortage of chairs, adult members can request the managers to assist them in locating lounges.

h. Private chairs and umbrellas will not be permitted on pool grounds, nor may chairs be placed on pool deck or concrete walks.

i. No abusive language.

j. No political activity of any kind on pool grounds.

k. No romancing of any kind on pool grounds.

l. No chewing gum permitted.

**m. ALL FOOD AND DRINK MUST BE CONSUMED IN THE PICNIC AREA ONLY.**

n. No selling or soliciting will be permitted on the pool grounds.
