

BOROUGH OF CRESSKILL
ORDINANCE NO. 18-15-1527

AN ORDINANCE TO AMEND CHAPTER 263 VEHICLES AND TRAFFIC

WHEREAS, the parking situation at the High School has been a problem with the increasing amount of vehicles searching for a spot. Students that cannot find a spot on campus then park in the surrounding neighborhood in the 2 hour limited zones; and

WHEREAS, after feedback from residents and further monitoring by the Traffic Bureau Division, the Mayor and Council agree to amend sections of Chapter 263 in an effort to help alleviate school related parking issues.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Cresskill, in the County of Bergen and State of New Jersey, as follows:

SECTION I:

SECTION 263-35. Schedule IV: Parking Time Limited. (added in **Bold**)

In accordance with the provisions of Section 263-10, no person shall park a vehicle for longer than the time limit shown upon any of the following streets or parts of streets:

Name of Street	Side	Time Limit; Hours/Days	Location
Delmar Avenue	Both	2 hrs; school days 8 a.m. to 4 p.m. Exception	From Piermont Road to Rose Street Bridge west/bound on south side of street for 70 feet
Morningside Avenue	Both	2 hrs; school days 8 a.m. to 4 p.m. Exception	From Piermont Road to Rose Street Bridge west/bound on south side of street for 93 feet
Park Avenue	Both	2 hrs; school days 8 a.m. to 4 p.m. Exception	From Piermont Road to Rose Street 50 foot mark away from stop sign at Piermont

**Road along North side
of road for 275 feet**

SECTION II:

Chapter 263 of the Code of the Borough of Cresskill is hereby amended by adding thereto the following:

SECTION 263-33. Schedule II: No Parking Certain Hours.

In accordance with the provisions of Section 263-8, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Mezzine Drive	Both	8:00 a.m. to 10:00 a.m. School days Exception	From Brookside Avenue east to end From Gilmore Avenue south side of street, east to cul-de-sac

SECTION III

All other Ordinances of the Borough, or parts thereof, which are in conflict with this Ordinance, are hereby repealed to the extent of such conflict.

SECTION IV

If any section, subsection, paragraph, subdivision, or sentence of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such decision shall apply only to the section, subsection, paragraph, subdivision, sentence, clause, phrase or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.

SECTION V

This Ordinance shall take effect immediately upon final passage and publication according to law.
