- 1. That the specifications for the Cresskill Fire Department Roof Replacement be and the same are hereby approved.
- 2. That immediately upon said approval and not later than thirty (30) days after the date thereof, the Clerk of this body be and hereby is directed to advertise for bids for the project at least ten (10) days before receipt of bids in <u>The Record</u>, a paper printed in this County.
- 3. That said advertisement shall read as follows:

Sealed Bids for <u>Cresskill Fire Department Roof Replacement</u> will be received by the Borough of Cresskill, in the County of Bergen, and State of New Jersey, at the Municipal Office Building, 67 Union Avenue, Borough of Cresskill, New Jersey, on <u>Wednesday</u>, <u>February 22, 2023</u>, at <u>11:00 AM</u>, Prevailing Time, and then publicly opened and read aloud.

The Work of Project is defined by the Contract Documents and includes, but is not limited to, the installation of new asphalt shingle roofing system, gutters, leaders and trim and other Work indicated in the Contact Documents. The existing roofing is to be removed to the deck.

The work of this project shall be completed no later than 90 days from notice to proceed, weather permitting.

Copies of the Plans, Specifications and Contract Documents will be on file and open to public inspection at the Borough Clerk's Office, Municipal Building, 67 Union Avenue, Borough of Cresskill, New Jersey, on and after Friday_January 20, 2023_, between the hours of 9:00 AM and 4:00 PM, Prevailing Time. The Bid Documents may be obtained directly from the Architect's office as an electronic PDF document. Bidders must request bid documents via email at office@aiarchs.com. All questions regarding the project should be directed to the Architect and received in writing only via email to: office@aiarchs.com.

Each Bid must be made upon the prescribed forms furnished with the Contract Drawings and Specifications, must be accompanied by a Consent of Surety, and by a certified or cashier's check, drawn on a solvent bank, or bid bond, in the sum of ten percent (10%) of the amount bid, but in no case more than \$20,000.00. The check or bid bond shall be made payable to the Borough of Cresskill, the Owner. The check or bid bond of the bidder to whom the Contract is awarded shall be held by the Owner as a guarantee that the Contract shall be executed and its performance properly secured and in default thereof, said check or bid bond and the amount represented thereby will be forfeited to the aforesaid Owner as liquidated damages. Bids must be accompanied, in the case of corporations not chartered in the State of New Jersey, by proper certificate that such corporation is authorized to do business in the State of New Jersey.

Bidders electing to receive the specifications from a third party, or any other service or entity assume the responsibility of ensuring they receive any issued revisions or addenda.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.

Every corporation or partnership submitting a bid shall accompany said bid with a statement setting forth the names and addresses of all stockholders in the corporation who own ten percent (10%) or more of its stock of any class, or of all individual partners in the partnership who own a ten percent (10%) or greater interest therein. Said statement may also be submitted prior to the bid.

Any extra work, not originally contemplated under this Contract, shall be covered by a change order. In the event that such extra work involves labor or material for which a unit price has been bid, the aforementioned unit price which has been bid, shall be used to fix payment for this extra work, and shall be the maximum payable by the Borough therefor.

Each bid must be enclosed in a sealed envelope bearing the name and address of the bidder, be addressed to the Borough of Cresskill, Bergen County, New Jersey, and shall be endorsed: "Cresskill Fire Department Roof Replacement, ENCLOSED - DO NOT OPEN". The Borough of Cresskill reserves the right to reject any and all bids, to waive any informalities or irregularities in the bids received, and to accept the bid from the lowest responsible bidder.

Mr. Fink said he heard the water is from a house above him that had work done to alleviate the water flow from their property. Clerk Maragliano said she will talk to the Building Dept. as they have been up to Eisenhower Drive for water issues.

Stephanie Cropper, 217 9th Street asked who will receive the US Army Corp. of Engineers report on the High School flooding. The BOE said they have no information to provide. Mayor Romeo said we haven't received it yet. We will let the residents know when we get it so they can review it. Ms. Cropper asked if there's any mitigation that can be done before their report. Council Member Olmo said we can't dig or do any work on the brook. Ms. Cropper thanked the Mayor & Council for pressing the BOE to put the muscle wall up. Parents were also asking, and we were told it would be taken care of. Ms. Cropper asked if the BOE liaison contacted the new School Supt. Dr. Hughes. Mayor Romeo said he and Chief Domville met with Dr. Hughes and had a good meeting. We asked for better communication between the BOE and ourselves.
