As BOE liaison, I've received calls that the air conditioning system was broken at the high school. I think it's been fixed but not certain. It's also broken at Bryan School, but I don't believe they have the funds to repair it. There have been complaints about no food or drinks following the 8th grade moving up ceremony and the yearly pool party which has been a past practice at both school sponsored events. Administrator Lavin said the HSA was contacted and provided pizza for the moving up ceremony. Council Member Olmo said he checked the BOE's meeting minutes for information, but the last minutes posted were from April. We offered the services of our OEM Coordinator Chief Ulshoefer to help with their FEMA funding and paperwork. Chief Ulshoefer said they have multiple outstanding projects and filed extensions a couple of months ago. They are also looking to see if they can be reimbursed for the interest of almost \$500K per year which they are paying out of their operating budget.

30. <u>RESOLUTION No. 2023</u>

WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund ("County Trust Fund"), provides matching grants to municipal governments and to nonprofit organizations for assistance in the development or redevelopment of municipal recreation facilities; and,

WHEREAS, the Borough of Cresskill desires to further the public interest by obtaining a grant of \$125,000 from the County Trust Fund to fund the following project: Replace the exiting age 2 to 5 year old composite playground structure with new equipment designed for children of ages 5-12 all situated within the already developed areas of Cranford park. Additionally, the Borough proposes to install a sports lighting system as part of phase 2 of the proposed Basketball Court Improvement about to be constructed, which project is funded in part with a 2018 municipal park improvement grant.

WHEREAS, the Mayor and Council has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions and desires to make an application for such a matching grant and provide application information and furnish such documents as may be required; and,

WHEREAS, as part of the application process, the Mayor and Council will hold a public hearing on June 21, 2023 to receive public comments prior to the submission of said application; and,

WHEREAS, the County of Bergen shall determine whether the application is complete and in conformance with the scope and intent of the County Trust Fund; and,

WHEREAS, the Borough of Cresskill is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the above named project and ensure its completion on or about the project expiration date.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Cresskill:

- 1. That it is hereby authorized to submit the above completed project application to the County by the deadline of May 12, 2023, as established by the County; and
- 2. That, in the event of a County Trust Fund award that may be less than the grant amount requested above, the Borough of Cresskill has, or will secure, the balance of funding necessary to complete the project, or modify the project as necessary; and,
- 3. That the Borough of Cresskill is committed to providing a dollar-for-dollar cash match for the project; and
- 4. That the Borough of Cresskill agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and
- 5. That this resolution shall take effect immediately.

An issue we are encountering in the Fire Prevention Bureau is that we have close to 400 rentals in town, many that we were not aware of, some we found out about from neighbors. We have come across a few homes where they are renting rooms to use the school system. We have to try to find the rentals and make certain they are safe. The inspections also bring in revenue.

Mayor Romeo said there are kids riding around on scooters with no helmets. Is there any way to force them to wear one? Chief Domville said we currently do not have an electric bike/electric scooter ordinance. I spoke to Attorney Diktas about it and Officer Grubecki is working with Bergen County traffic.
