# Report from the Borough Engineer's Office

Mr. Azzolina had nothing to report, other than the receipt of Application #1555. He will report on it at the next meeting.

He spoke to the applicant's surveyor for the Kim subdivision regarding the overlap issue that was brought to the Board's attention by the neighbor. They are investing that, and he recommended that he investigate it fully because it has a material impact on the amount of property available to subdivide. They are doing additional survey work.

Mr. Schuster thinks that at this point we should dismiss it and they can refile it. This is going on too long. We don't know how soon this will be resolved. It has been carried several times already. He would rather dismiss it and they can refile it. That way you don't have to worry about the extension and time to act on it. This is a better way to do that.

Mayor Romeo asked if this has already been carried. Mr. Schuster noted that it has already been carried. Mayor Romeo stated that he called today and called it off because his surveyor is coming and doing a new survey. Mr. Paul Nelson was present and said he is okay with whatever the Board decides. He just wants to make sure the interest of the property line is taken care of. He presented the Board with a memo that he wrote with the particulars of the property line. Mr. Schuster stated that this will not be evidentiary for the hearing. Mr. Azzolina asked if he had any information about the Petrino application and if it ever advanced because he doesn't have anything in his files relative to that. Mr. Nelson stated that he doesn't know if it did or not.
